### **Services for victims of domestic violence, sexual assault and other crimes.**

- All client services are **provided at no charge to clients**, are **confidential** and can be **anonymous**.
- Services are offered to all communities in Westmoreland County.
- All counselors/advocates are trained in the dynamics of violence and trauma and understand the complex issues involved.

#### **24-HOUR HOTLINE**

---

- The hotline provides 24 hour crisis counseling.
- The hotline is available to anyone who has been impacted by a violent or abusive event – victims, their family and friends, community members and professionals who seek information about how they might better meet the needs of their clients who are victims.

#### **COUNSELING and THERAPY**

---

In-person counseling and therapy is available for anyone who has been impacted by violence or abuse: victims, their family and friends, and community members.

#### **MEDICAL ACCOMPANIMENT**

---

Medical Advocates meet victims at the emergency room of any Westmoreland County hospital, 24/7, to provide support during medical examinations and information about resources and options.

#### **LEGAL ACCOMPANIMENT**

---

Legal Advocates accompany victims, and their families and friends, through the legal system, to provide support in navigating the complex legal system, and discuss victims' rights and options.

#### **SUPPORT GROUPS**

---

Blackburn Center staff provides weekly support groups for victims of violence, and those who are close to them. Groups may be offered for:

- Female or male adult victims
- Child or teen victims
- Children of victims
- Adults sexually abused as children
- Significant others of victims

#### **SHELTER**

---

Temporary emergency shelter (up to 30 days in a six-month period) is available to victims of intimate partner violence and their children. The shelter provides a safe, comfortable haven where residents can plan for their future.

#### **TRAUMA-INFORMED YOGA**

---

Yoga is a powerful tool in the healing process for trauma survivors. Blackburn Center offers trauma-informed yoga groups for clients.

#### **EDUCATION and PREVENTION PROGRAMS**

---

Blackburn Center provides education across Westmoreland County to deepen the community's understanding of the dynamics of domestic and sexual violence, and the availability of services; and engage the community in its comprehensive primary prevention initiative to put an end to this violence. Strategies include:

- Campus-based programs
- Community and school-based programs
- In-service trainings for professionals
- Social media outreach
- Community-wide events

#### **BLACKBURN LEGAL**

---

This program provides civil legal services to victims of crime for issues that are related to victimization they have experienced, providing them with services that will benefit them in the aftermath of a crime.
